HAZARDOUS WASTE DROP-OFF SITES IN LAFAYETTE COUNTY

The City of Concordia, Missouri offers a hazardous waste drop-off site every Thursday from 10:00 am —1:00 pm. You must call to schedule an appointment. The number to call is: 660-463-2228. Please ask for Dale.

The City of Lexington, Missouri also offers hazardous waste drop-off. Their drop-off days are on the 2nd and 4th Tuesday of the month from 9 am—12 noon. The number to schedule an appointment is 660-232-3827.

CITY FISHING AND BOATING PERMITS

At this time, City Permits for fishing and boating will not be required through April 30, 2020. Normally, permits for fishing and boating will be sold at City Hall from Monday—Friday, 8:30 am to 5:00 pm. You can also purchase them at the Odessa Police Department (816-633-7575) anytime. You must bring exact change to the Police Department. Prices are listed below.

Daily Fishing Permit is \$2.00 ~ Season Fishing Permit is \$8.00 ~ Season Boating Permit is \$8.00

HEARTLAND OFFERS YARD WASTE PICK-UP

Heartland Waste offers yard waste pick-up from April through November. The cost for the entire period is \$32. A one time pick-up charge is \$1 per bag with a \$5 dollar minimum. BE SMART: DO YOUR PART
