Update on the Closure of City Hall

During budget discussions in February of this year, estimates were included to renovate the front lobby of City Hall to provide additional security and improve the safety of our government building. This project was approved to be completed within the current budget. Now that we have encountered a global pandemic, this renovation is even more critical to help protect the health of not only our employees but the public that enters the building. We feel that moving forward with the construction while keeping City Hall closed will create minimal interruption while allowing it to be completed as quickly as possible.

Please know that our staff continues to work from City Hall, Monday through Friday, 8:30 am - 5:00 pm. Despite the change to our traditional ways of operation, we are committed to providing professional service to our customers. You may pay your utility bill online or over the phone, or by dropping it off at one of the two drop boxes as City Hall. The fee to use a credit/debit card will remain waived during the building closure. Fishing/boating permits for the city reservoir will continue to be waived. And our staff will assure that any items of business that would normally be completed at the front counter will continue to be accomplished. Missouri Primacy Fee & Sewer Connection

The State of Missouri, through the Department of Natural Resources, requires community water systems to collect a Primacy Fee and a Sewer Connection Fee from each customer to pay for the administration of the Safe Drinking Water Act. This fee appears on the enclosed utility bill as a once a year charge. All fees collected are sent to the Missouri Department of Natural Resources. Level pay customers will see this amount as an addition to this month's level bill only.

Parks & Recreation

The Odessa Aquatic Center opens on July 1, 2020, with some restrictions in place. No lounge chairs or tables will be available. You may bring a lawn chair or towel to sit on. The concession stand will only be selling prepackaged food. There will be increased cleaning of bathrooms and shared surfaces. Social distancing should be maintained. Season passes for the pool will not be available this year.

Daily admission is \$5 for ages 3 and up. Hours of operation are 1:00-6:00 pm every day of the week except on Fridays, which is 1:00-7:00 pm. Swimming lessons will begin on July 20. Pool party rentals are available seven days a week. Please contact the Park office at 816-633-8324 for additional information.

Odessa Business Licenses

City business licenses are due July 1. The fee to renew an Odessa business license from July 1, 2020, through June 30, 2021, has been waived. This does not include new business licenses. All other rules and requirements apply. Businesses located in buildings in Odessa are required to have an annual safety inspection before licenses are issued. Municipal Court – Fine Payment

Certain citations may be paid prior to court rather than exercising your right to have the case heard by a judge including minor traffic violations, plate violations, license violations, and animal violations. Violations that include any personal or property damage, DWI, or driving while suspended/revoked require a court appearance. Fourth of July Holiday

Odessa residents may shoot off fireworks within city limits on July 3, 4, and 5 during the hours of 8:00 am to 10:00 pm on residential property with the following restrictions:

- No fireworks may be ignited on a public street
- Bottle rocket fireworks are prohibited
- No fireworks may be ignited within 600 feet of a church or school
- Ignited fireworks may not be thrown from, into, or at a motor vehicle

The VFW will have a fireworks display on July 4 at Dyer Park starting around 9:00 pm.

The loud noise of fireworks can be very frightening to many pets and cause them to run if left unattended and/or loose. Please keep your animals at home in a quiet, sheltered, and escape-proof area of your home. You can also speak with your veterinarian about medications that will calm a nervous pet.
