INSTRUCTIONS FOR GUILTY PLEA PRIOR TO COURT DATE

The following procedure has been established for the convenience of those who prefer to plead guilty and dispose of certain ordinance violations prior to their court date and thereby avoid the inconvenience, delay, and expense incident to court appearances, cash bonds, and related matters.

The attached fine schedule has been authorized by the Missouri Supreme Court for use by those who elect to handle their case prior to their court date.

Court Costs for each case are set by Missouri State Law and **MUST BE INCLUDED** even if you do not personally appear in court.

To dispose of your case prior to the assigned court date you **MUST**:

1. Sign the *Appearance, Plea of Guilty and Waiver* on the back of the Citation.
2. Pay the designated Fine and Court Costs by either cash or money order payable to the City of Odessa.
3. You may deposit the signed Citation and designated amount in person or by mail to:

VIOLATIONS BUREAU SCHEDULE OF FINES

- Only the following violations may be paid in advance without a court appearance.
- Payment of fine constitutes a guilty plea, waiver of trial, and possible points assessment.
- Violations may not include any personal or property damage, DWI, or driving while suspended/revoked.
